

Terms and conditions of participation in LinkedIn competitions

Doppelmayr Seilbahnen GmbH

These terms and conditions govern the conditions for participation in the current LinkedIn competition of Doppelmayr Seilbahnen GmbH.

The participant accepts the conditions of participation for the current LinkedIn competition by participating.

The organizer of the competition is Doppelmayr Seilbahnen GmbH, Konrad-Doppelmayr-Straße 1, 6922 Wolfurt, Austria.

Eligibility:

All persons who are at least 18 years of age at the time of entry are eligible to participate. Participation is also only possible if the participant does not violate any compliance guidelines that apply to him/her (e.g. gift acceptance guidelines for employees of customers of the organizer).

All employees of Doppelmayr Seilbahnen GmbH and affiliated companies are excluded from participation. Participation by public officials is also excluded.

Participation with forged identities or with identities of third parties is not permitted.

Participation:

Eligible persons can participate in the competition by setting the actions described in the respective competition (e.g. become a follower, link, etc.).

Participation is possible until the deadline stated in the competition description.

Prizes:

Doppelmayr Seilbahnen GmbH will draw the prizes listed in the competition description from among all eligible participants, provided the prerequisites for winning are met.

Winners will be selected at random from all eligible participants within one week of the closing date. Winners will be notified via the comment function or in a separate post and requested to contact the organizer within five working days via a personal message on the LinkedIn with address data. If a winner does not get in touch within this period, the prize will be forfeited.

The prize is neither transferable nor can the prize be exchanged. Legal recourse and cash payment are excluded. Only one prize is possible per participant. The distribution of the prize will be made by the organizer. The prize will be sent to the winner.

Doppelmayr is entitled to permanently publish winners with their first name and the first letter of the last name as well as the content published for participation on LinkedIn where the competition was announced.

Responsibility for and rights to the participant's content:

The participant grants the organizer a free, simple, worldwide valid, permanent, transferable and sublicensable right of use to the content published on LinkedIn for promotional/communicative purposes in connection with the competition, in particular for advertising, presentation as well as documentation of the competition. This includes, in particular, the right to reproduce, distribute and publicly reproduce the contributions with images or comments.

The participant assures that content published by him/her on the LinkedIn is free of third-party rights and in this respect indemnifies the organizer against third-party claims. Participants are solely responsible for all content they provide on the LinkedIn in connection with the competition. The content may not be insulting to other users or third parties and may not defame, harass or harm other users or third parties in any way, violate any (other) third party rights (in particular personal rights, copyrights and ancillary copyrights), advertise for third parties (in the form of links, texts and/or images) and may not contain immoral, obscene, pornographic, threatening, violent, discriminatory or racist items.

Exclusion and changes:

In case of violation of these conditions of participation, the organizer is entitled to subsequently exclude the participant from participation. This applies in particular if an eligibility is not given or false information is given as well as in case of publication of infringing content by the participant on the LinkedIn of the organizer. Such content may be deleted by the organizer without further notice. If the excluded participant is a winner who has already been drawn, the prize may be subsequently revoked. A substitute drawing will not take place.

The organizer reserves the right to terminate the competition prematurely in whole or in part at any time, even without observing any deadlines, or to change its course if it is not possible for technical (e.g. computer virus, manipulation of or errors in software/hardware) or legal reasons to guarantee proper implementation of the competition.

Disclaimer:

The competition is in no way connected to the LinkedIn and is in no way sponsored, supported or organized by it. Each participant indemnifies the LinkedIn from claims in connection with the competition. Final provisions:

Should the terms and conditions of participation contain invalid provisions, the validity of the remaining terms and conditions shall remain unaffected.

The laws of the Republic of Austria shall apply.

For all legal disputes arising from or in connection with these conditions of participation and the competition, the organizer's registered office is agreed as the place of jurisdiction.

Data protection notice:

If you participate in the competition, we, as the data protection controller, will process the personal data of you associated with participation and disclosed by you to us in order to carry out the competition and to identify you as an eligible participant, as well as for any prize determination and notification and the dispatch of any prize.

This processing of data is carried out upon your participation and is necessary for the aforementioned purposes for your participation and the implementation and execution of the competition in accordance with Art. 6 para. 1 p. 1 lit. b DSGVO.

Data will only be passed on if this is necessary in the context of the competition (e.g. delivery of the prize).

Further processing by us will not take place. The winners' personal data will generally be deleted no earlier than 3 years at the end of the year following the end of the competition.

Earlier deletion is not possible in order to be able to trace the participations in the context of a legal claim. Please note, however, that the content you publish as part of your participation is linked to your name and also to your social media profile and can therefore be permanently accessed via our page on the LinkedIn. Please note the settings option for the public visibility of your profile on the LinkedIn.
